## **Healthcare Apprenticeships**



### **Healthcare Support Worker**

Level: 2

**Duration: 12 Months\*** 

Funding Band: £3000 (Standard)

A Healthcare Support Worker is part of a team providing high quality and compassionate care to individuals, carrying out well defined clinical duties, checking on overall progress, comfort and wellbeing.

You will train alongside your employer in the workplace, undertaking units such as: Communication, Health Intervention, Personal development, and Equality and diversity.

Mandatory Qualifications; Apprentices without Level 1 English and Maths will need to achieve this level and take the test for Level 2 English and Maths prior to completion of their Apprenticeship, You will also be supported to achieve the Care Certificate.

## Senior Healthcare Support Worker

Level: 3

**Duration: 24 Months\*** 

Funding Band: £5000 (Standard)

As a **Senior Healthcare Support** Worker you will provide high quality, compassionate healthcare, following standards and policies.

You may work in a range of services e.g. hospital, community, midwifery led unit, operating theatre, nursing or care home, GP surgery, etc.

Mandatory Qualifications; Level 2 in English and Maths. You must complete a Level 3 Diploma in Healthcare Support prior to taking the end-point assessment, you will also be supported to achieve the Care Certificate.

## **Healthcare Cleaning Operative**

Level: 2

**Duration:** 12 months\*

Funding Band: £4000 (Standard)

Healthcare Cleaning Operatives may work in establishments that require cleaning to a healthcare standard to prevent adverse effects on the health of high-risk service users, such as; hospitals, care homes, Healthcare settings within prisons and schools.

Those undertaking this apprenticeship, their role must solely be for the purpose of cleaning such areas and they must be able to achieve the full breadth of the knowledge, skills and behaviours required to successfully complete this apprenticeship within their everyday role.

## Healthcare



#### **Healthcare Science Assistant**

Level: 2

**Duration: 12 months\*** 

Funding Band: £5000 (Standard)

The Healthcare Science Assistant (HCSA) typically supports safe patient care across all care pathways from conception to end of life in job roles within hospitals, general practice and other settings in the healthcare sector and across all areas of healthcare science

HCSAs perform a range of low risk, routine technical and scientific procedures usually within one broad area of HCS, following specific protocols and in accordance with health, safety, governance and ethical requirements. HCSAs work using standard operating procedures, initially under direct supervision but increasingly with experience, under indirect supervision.

Mandatory Qualifications; The AHCS will require the Level 2 Diploma in Healthcare Science as an underpinning qualification for the HCSA apprenticeship. Apprentices must

### **Healthcare Science Associate**

Level: 4

**Duration: 24 Months\*** 

Funding Bands: £9000 (Standard)

Healthcare Science Associates typically work in hospitals, primary care and other healthcare settings, carrying out routine technical and scientific procedures. Supporting healthcare science (HCS) practitioners and clinical scientists.

HCSA's perform high quality, safe diagnostic, therapeutic and monitoring technical and scientific procedures from conception to end of life in job roles within hospitals, general practice and other settings in the healthcare sector and across all areas of HCS. They perform a wide range of routine technical and scientific procedures, with minimal supervision, within one of the Divisions in HCS

Mandatory Qualifications;
The AHCS will require the Level 4
Diploma in HCS as an underpinning
qualification for the HCS Associate
apprenticeship. Apprentices

## **Adult Social Care Apprenticeships**



#### **Adult Care Worker**

Level: 2

**Duration:** 12 Months \*

Funding Band: £4000 (Standard)

The Adult Care Worker role is key in the delivery of care and support to individuals in a number of different settings and situations. Employment opportunities range from residential care homes and care-at-home services, to supporting individuals to develop skills that enable them to live their lives with increasing independence and to reach their full potential.

Mandatory Qualifications; Functional Skills in English and Maths, Care Certificate. You must also Undertake the Enhanced Disclosure and Barring Service process and provide the result prior to starting

#### **Lead Adult Care Worker**

Level: 3

**Duration:** 18 Months \*

Funding Band: £4000 (Standard)

As a Lead Adult Care Worker you will make a positive difference to someone's life when they are faced with physical, practical, social, emotional or intellectual challenges. You will be expected to exercise judgement and take appropriate action to support individuals to maintain their independence, dignity and control.

Mandatory Qualifications; Functional Skills in English and Maths, Care Certificate. You must also Undertake the Enhanced Disclosure and Barring Service process and provide the result prior to starting

## **Adult Social Care**



#### **Lead Practitioner in Adult Care**

Level: 4

**Duration:** 18 Months\*

Funding Band: £7000 (Standard)

The Lead Practitioner in Adult Care will guide and inspire team members to make positive differences to someone's life when they are faced with physical, practical, social, emotional, psychological or intellectual challenges.

They will have achieved a level of self-development to be recognised as a lead practitioner within the care team. This standard also covers Lead Personal Assistants who can work at this senior level but they may only work directly for one individual who needs support and/or care services, usually within their own home.

Qualifications; Functional Skills in English and Maths, Level 4 Diploma in Adult Care.

#### Leader in Adult Care

Level: 5

**Duration:** 18 Months\*

Funding Band: £7000 (Standard)

The Leader in Adult Care will guide and inspire teams to make positive differences to someone's life when they are faced with physical, practical, social, emotional, psychological or intellectual challenges.

They will be a leader of the care team and will develop and implement a values-based culture at a service or unit level.

They may be responsible for business development, financial control, organisational resilience and continuity as well as for managing risk and leading on organisational change.

Qualifications; Functional Skills in English and Maths, Level 5 Diploma in Leadership & Management for Adult

## **Early Years Educator**

Level: 3

**Duration:** 18 Months minimum\* **Funding Bands:** £6000 (Standard)

Early Years Educators, nursery nurses, and childminders are highly trained professionals who play a vital role in helping young children learn, develop, and stay safe. They work in various settings like day-cares, children's centres, and preschools. They may either be working on their own or supervising others to deliver the Early Years Foundation Stage (EYFS) requirements set by Government for the learning, development and care of children from birth to 5 years old. The apprentice will also complete a first aid qualification in line with the requirements of the Early Years Foundation Stage Framework.

Mandatory Qualifications; Apprentices without level 2 English and maths will need to achieve this level prior to taking the End-Point Assessment. For those with an education, health and care plan or a legacy statement, the apprenticeship's English and maths minimum requirement is Entry Level 3. A British Sign Language (BSL) qualification is an alternative to the English qualification for those whose primary language is BSL.

## **Business, Leadership & Management**



#### **Team Leader/Supervisor**

Level: 3

**Duration:** 12 months\*

Funding Band: £4500 (Standard)

A Team Leader is a first line management role which has operational / project responsibilities for managing a team to deliver a clearly defined outcome. They provide direction, instructions and guidance to ensure the achievement of set goals. Key responsibilities are likely to include supporting, managing and developing team members, managing projects, planning and monitoring workloads and resources, delivering operational plans, resolving problems and building relationships internally and externally

Mandatory Qualifications; You may be required to take Functional Skills in English and Maths.

## **Associate Project Manager**

Level: 4

**Duration:** 24 Months minimum\* **Funding Band:** £6000 (Standard)

This course has been designed to help you develop the Associate Project Manager skills that are used in your daily job role. Associate project managers need good planning, organisation, leadership, management and communication skills. Dependent upon the size of the organisations and the complexity of projects, associate project managers' job titles will vary, but typically they can include: assistant project manager, junior project manager, project team leader.

Mandatory Qualifications; You will be required to have Project management qualification recognised by the APM Project Management Qualification You may be required to take Functional Skills in English and Maths.

#### **Customer Services Practitioner**

Level: 2

**Duration:** 12 Months minimum\* **Funding Band:** £3500 (Standard)

A Customer Service Practitioner delivers high quality products and services to the customers of their organisation. Core responsibilities include one off or routine contacts, dealing with orders or payments, offering advice, guidance and support, meet and greet, sales and aftercare.

You will train alongside your employer in the workplace, undertaking units such as: Knowing your customers, Dealing with customer conflict and challenge, Influencing skills, and Communication

Mandatory Qualifications; You may be required to take Functional Skills in English and Maths.

## **Customer Service Specialist**

Level: 3

**Duration:** 15 Months minimum\* **Funding Bands:** £4000 (Standard)

A **Customer Service Specialist** will be a 'professional' for direct customer support within all sectors and organisation types.

You will gather and analyse data and customer information that influences change and improvements in service. Utilising both organisational and generic IT systems to carry out your role with an awareness of other digital technologies.

Mandatory Qualifications; You may be required to take Functional Skills in English and Maths. Completion of this apprenticeship will lead to eligibility to join the Institute of Customer Service as an Individual member at Professional level.

# Operations/Departmental Manager

Level: 5

**Duration: 30 Months\*** 

Funding Band: £7000 (Standard)

An Operations/Departmental manager manages teams and/or projects, and achieves operational or departmental goals and objectives as part of the delivery of the strategy of the organisation. They are accountable to a more senior manager or business owner. Key responsibilities may include creating and delivering operational plans, managing projects, leading and managing teams, managing change, financial and resource management, talent management, coaching and mentoring.

Mandatory Qualifications; You may be required to take Functional Skills in English and Maths.

## **HR Support**

Level: 3

**Duration:** 18 months\*

Funding Band: £4500 (Standard)

HR Professionals in this role are typically either working in a medium to large organisation as part of the HR function delivering front line support to managers and employees, or are a HR Manager in a small organisation

This course will cover topics such as; Business Understanding, HR Legislation & Policy, HR Function, HR Systems & Processes, Service Delivery, Process Improvement, Managing HR information and much more.

Mandatory Qualifications; You may be required to take Functional Skills in English and Maths.

#### **Business Administrator**

Level: 3

**Duration: 18 Months\*** 

Funding Band: £5000 (Standard)

Business administrators have a highly transferable set of knowledge, skills and behaviours that can be applied in all sectors. This includes small and large businesses alike; from the public sector, private sector and charitable sector. The responsibilities of the role are to support and engage with different parts of the organisation and interact with internal or external customers.

Mandatory Qualifications; You may be required to take Functional Skills in English and Maths.

#### **School Business Professional**

Level: 4

**Duration:** 18 Months\*


Funding Band: £6000 (Standard)

School Business Professionals (SBPs) perform a role which is unique to schools, administering and managing the financial, site and support services within the school context. They provide essential support to school leadership teams, implementing their financial and business decisions.

## **Business Analyst**

Level: 4

**Duration: 18 Months minimum\*** 

Funding Bands: £18000 (Standard)

The broad purpose of the occupation is to understand the needs of stakeholders and how these can be met through business change and digital solutions. Business Analysts are change professionals that help organisations deliver business and digital change successfully. Business Analysts will determine and present solutions of how technology can be used to deliver business improvements, and support business acceptance to ensure that the proposed solution meets the defined requirements.

Mandatory Qualifications; Apprentices without level 2 English and maths will need to achieve this level prior to taking the End-Point Assessment. For those with an education, health and care plan or a legacy statement, the apprenticeship's English and maths minimum requirement is Entry Level 3. A British Sign Language (BSL) qualification is an alternative to the English qualification for those whose primary language is BSL.

This standard aligns with the following professional recognition:

BCS, The Chartered Institute for IT for Register of IT Technicians (RITTech) level 4

#### **Data Protection & Information Governance Practitioner**

Level: 4

**Duration: 18 Months\*** 

Funding Band: £10000 (Standard)

An employee in this occupation will be responsible for assisting the organisation in its compliance with information governance and data protection best practice and associated laws and regulations. In their daily work, an employee in this occupation interacts with a range of internal stakeholders including members of their own team, other departments such as IT, legal, HR, marketing, senior management and the board of directors. They also interact with external stakeholders such as members of the public, customers, Supervisory Authorities, The Information Commissioner's Office (ICO), technology vendors, academics, industry bodies, external legal departments, human rights organisations, consumer rights organisations and law enforcement.

Mandatory Qualifications; Apprentices without level 2 English and maths will need to achieve this level prior to taking the End-Point Assessment. For those with an education, health and care plan or a legacy statement, the apprenticeship's English and maths minimum requirement is Entry Level 3. A British Sign Language (BSL) qualification is an alternative to the English qualification for those whose primary language is BSL.

This standard aligns with the following professional recognition: Information and Records Management Society for Individual member grade and The British Computer Society for Associate member grade .

## **Data Analyst**

Level: 4

**Duration: 24 Months minimum\*** 

Funding Bands: £15000 (Standard)

The primary role of a Data Analyst is to collect, organise and study data to provide business insight. Data analysts are typically involved with managing, cleansing, abstracting and aggregating data, and conducting a range of analytical studies on that data. They work across a variety of projects, providing data solutions to a range of stakeholders/customers issues.

## **Warehousing & Logistics**



## **Supply Chain Warehouse Operative**

Level: 2

**Duration:** 12 Months minimum\* **Funding Band:** £3000 (Standard)

Warehouse Operatives work in a variety of warehouse environments. Work activities include taking deliveries, checking for damaged/missing items, storing goods, moving stock by various methods, picking/packing orders, loading goods for dispatch, maintaining stock records and documentation, and cleaning. They are required to safely use a range of equipment, machinery and vehicles, as relevant to their role and setting. This could include mechanical racking systems, materials handling equipment (MHE) or fork lift trucks.

Warehouse Operatives communicate with a wide range of people and customers. They have a passion to meet customers' expectations by providing a quality service that encourages repeat business. Individuals in this role are highly competent in using industry-recognised systems and associated services (eg Traffic/Warehouse Management Systems) and will be able to work under pressure to tight deadlines.

## **Prevent & Safeguarding**



The Prevent Duty is not about preventing our learners from having political or religious views and concerns but about supporting them to address those concerns or act on them in non-extremist ways.

Steadfast Training Ltd aim to promote British Values in our work and build our learners resilience to radicalization.

Prevent Strategy is part of the Governments Counter-Terrorism and Security Act 2015 (the Act) places a duty on certain bodies in the exercise of their functions, to have "due regard to the need to prevent people from being drawn into terrorism". This guidance is issued under section 29 of the Act. The Act states that the authorities subject to the provisions must have regard to this guidance when carrying out the duty.

The Prevent strategy was explicitly changed in 2011 to deal with all forms of terrorism and with non-violent extremism, which can create an atmosphere conducive to terrorism and can popularise views which terrorists then exploit. It also made clear that preventing people becoming terrorists or supporting terrorism requires challenge to extremist ideas where they are used to legitimise terrorism and are shared by terrorist groups. And the strategy also means intervening to stop people moving from extremist (albeit legal) groups into terrorist-related activity.

#### **Safeguarding**
